Our Precious Forests



Put on your Nike's and try this. Imagine walking from Southport to Main River or Robina Town Center to Mudgeeraba or from Currumbin Beach to Tugun or Hope Island to Sanctuary Cove. These walking distances have one thing in common in that they are about 2 km or just over 1.2 miles. Most people with reasonable health could walk that, given a little time because relative to so many other journeys it's not far as the crow flies. We walk at about 4 km an hour so at that rate it would take around half an hour to cover the distance. Now that you have a feel for how far 2km is, imagine that distance straight skyward and the result is you would be out of breathable atmosphere. This thin band of air around planet earth is all we have in terms of a minimum life sustaining oxygen level of just 16% at around 2 km or 1.2 miles. Earth's atmosphere at sea level contains about 21% oxygen but at 2 km it falls to just 16%. At 5km it's only 10% let alone at low pressure making breathing very difficult, while at the summit of mount Everest the oxygen level is a terminal 6%.

Now given this it would seem pretty important to me that we look after the atmosphere and especially oxygen levels. Green house gasses are another issue as well but I'm not referring to that today. All this begs the question, where does the earth's oxygen come from and surely as we burn it relentlessly its pretty important to ensure its replaced.
