Program 24 Small Business



During the nineteenth and twentieth century's right up to 1987 miners would take a canary into the coal mine. Canaries are very susceptible to methane and carbon monoxide gases and would fall silent and die well before the gas affected the miners thus providing an early warning signal. So the metaphor was created where an event or a warning can act as the 'canary in the mine'. Interestingly a variation on this occurred on board the Titanic where there was still a crow's nest lookout point. On that fateful night with a calm sea and full moon the duty lookout warned the bridge of ice bergs ahead. The bridge ignored the early warning as they couldn't see the ice on the moonlit ocean. The rest is history and most have never heard of the lookouts name. Mores' the pity because Fred Fleet was a maritime canary too.

You may well ask what has all this got to do with democracy and freedom which is the subject of these narratives. Well a great deal at the moment and it has to do with small business especially on the Gold Coast. It's statistically true that small and medium business is the back bone of our country and small business in particular is a vital part of business life especially on the Gold Coast which is the home of small business. Tell that to small business while the canary expires in the mine and we steam toward a sea of ice bergs at full speed. Common sense is no longer common, is it?
